

# Takeout Flatiron

## Win Dinner for a Year

OFFICIAL CONTEST RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

**1. Eligibility:** This Campaign is open to entrants who are 18 years of age or older as of the date of entry. The Campaign is only open to legal residents of New York, New Jersey and Connecticut (The Tri-State Area), and is void where prohibited by law. Staff of The Flatiron/23rd Street Partnership District Management Association (“The Partnership”), including all full & part-time Partnership staff, contracted vendors, or board members, (collectively “The Partnership Team”), and immediate family members and/or those living in the same household of “The Partnership Team” are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

**2. Agreement to Rules:** By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. You understand and agree that you are signing up to receive electronic communications via email from The Partnership and may unsubscribe at any time. In addition, You agree to accept the decisions of The Partnership as final and binding as it relates to the content of this Campaign.

**3. Campaign Period:** Entries will be accepted online for takeout orders placed (or alternate entries submitted) during the contest period starting on Monday, February 8, 2021 and ending Wednesday, March 31, 2021 at 11:59 pm EST. All online entries must be received by Friday, April 2, 2021 at 11:59 pm EST.

**4. How to Enter: NO PURCHASE NECESSARY. Submitting a takeout receipt is encouraged, but not necessary for entry.** The Campaign must be entered by emailing the Flatiron Partnership using the subject "Takeout Flatiron Contest" and including your legal name, email address, phone number, and home zip code, and receipt to [takeout@flatirondistrict.nyc](mailto:takeout@flatirondistrict.nyc). Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of The Partnership. You must provide the information requested. You may enter no more than once per day during the contest period. Date of entry will be determined by date of the takeout order on the receipt, or by the date on the email submission if no receipt is provided. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of The Partnership.

**5. Prizes:** Four (4) Grand Prize winners will receive the following: 12 restaurant gift certificates, totaling \$595 (Eleven \$50 gift cards, and one \$45 gift card). Actual and/or appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by The Partnership. No cash or other prize substitution shall be permitted except at The Partnership's discretion. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. If a prize awarded is not redeemed prior to the permanent closure of an establishment The Partnership will not provide an alternate or substitute prize. Winner will be selected by a random drawing under the supervision of The Partnership. Winner will be notified by email or phone call within five (5) days following selection of Winner. The Partnership shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 30 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this Campaign is conditioned upon compliance with any and all federal, state, and local laws and regulations. **9. Terms & Conditions:** The Partnership reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Campaign should virus, bug, non-authorized human intervention, fraud, or other cause beyond The Partnership's control corrupt or

affect the administration, security, fairness, or proper conduct of the Campaign. In such case, The Partnership may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by The Partnership. The Partnership reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions. The Partnership has the right, in its sole discretion, to maintain the integrity of the Campaign, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering.
